**Subject: Selection of Range Officer Grade-I Forest (Territorial) in the J&K Forest (Gazetted) Service.**

**Notification No. PSC/EXAM/67/2019**  
**Dated: 20.09.2019**

Whereas, the written examination for the posts of Range officer Grade-I Forest (Territorial) was held from 23.03.2019 to 14.04.2019; and,

Whereas, 09 candidates were allowed to submit their application forms on the directions of the Hon'ble High Court in SWP No. 857/2018, M.P. No.1/2018 titled Riyaz Ahmad Malik & Others Vs State of J&K & others. The operative part of the direction is reproduced as under:-

***“In the meantime, the Public Service Commission, shall accept the application forms of the petitioners on their own risk and responsibility”;*** and,

Whereas, 40 candidates qualified for interview on the basis of written examination; and,

Whereas, Hon'ble High Court in OWP No.436/2019, IA No.01/2019 titled Showkat Ahmad Bhat & Others V/S State and Others in its directions dated 08.04.2019 has directed the Commission not to finalize the selection of Range Officers Grade-I. The operative part of the order is given as under:-

***“In the meantime, subject to the objections and till next date before the Bench, respondents shall not finalise the selection of Range Officers, Grade-I, advertised pursuant to the advertisement notice No.PSC/Exam/2018/19 dated 15.03.2018”;*** and,

Whereas, the Hon'ble High Court has dismissed the OWP No.436/2019 [WPC No.1216/2019] titled Showkat Ahmad Bhat & Others V/S State and Others as withdrawn and vacated the interim order dated 08.04.2019. The operative part of the order is given as under: -

***“On the stated submission made by the learned counsel for the applicants/petitioners, permission is granted and writ petition shall stand dismissed as withdrawn. Interim order dated 08.04.2019 read with order dated 13.05.2019, shall stand vacated.”***

Now, on the basis of performance in the written examination held from 23.03.2019 to 14.04.2019, and, in the interview held w.e.f. 29.07.2019 to 31.07.2019, the candidates

as shown in **Annexure "B"** to this notification have **qualified for the Walk Test and Medical Examination** for the post of Range Officer Grade-I Forest (Territorial).

The Aggregate Merit of the 40 candidates who appeared in the interview is enclosed as "Annexure-A" to this notification.

07 posts under RBA category, 03 posts under SC category, 03 posts under ST category and 02 posts under ALC category has remained unfilled due to non-availability of candidates.

Instructions to appear before the Medical Board and for walk test should not mean that the candidate is necessarily given an appointment.

Necessary intimation to the candidates shown in "Annexure-B" for walk test and medical examination shall be sent separately.
