**Subject:- Select List for the posts of Assistant Professor (English Literature)
 in Higher Education Department**

Notification No. 27 – PSC (DR-S) of 2016

Whereas, the Higher Education Department referred 27 posts (OM:15, RBA:05, SC:03, ST:03, ALC:01) of Assistant Professor in the discipline of English Literature to the Public Service Commission for being filled up from amongst the suitable candidates ; and

whereas, the Commission notified these posts vide Notification No. 12-PSC(DR-P) of 2014 dated: 29.5.2014; and

whereas, in response to the above notification, 136 candidates had applied and out of which, 65 candidates were found provisionally eligible for the said posts; and

whereas, the interview of the eligible candidates was held from 7th to 10th January and 20th June, 2016 at Jammu and Srinagar respectively; and

whereas, the interview process had to be held in two phases in view of the fact that the Universities of Jammu and Kashmir withdrew the MSP certificates in respect of candidates, having applied on the basis of Ph.D degrees, rendering them ineligible for the post; and

whereas, the Public Service Commission was requested by the Higher Education Department to defer the process of finalization of selection till the issue of MSP is resolved in consultation with University Grants Commission; and

whereas, the issue of eligibility of Ph.D candidates was resolved by the UGC by way of issuance of a Notification No.F.1-2/2016(PS/Amendment) dated 4th May 2016; and

whereas, the revised MSP certificates were issued by the concerned Universities as per the amended UGC Regulations rendering them eligible or otherwise for the post; and

whereas, the petitioner figuring at S.No.66 in the General Merit List who is otherwise ineligible was interviewed on the Hon'ble High Court orders in SWP No.20/2016, MP No.01/2016 and SWP No.66/2016, titled Vishal Plathia & Others Vs State & Others, wherein the Hon'ble Court directed the Commission to conduct the interview of the petitioner on his own risk and responsibility and not to declare his result till the final outcome of the writ petition.

Now, therefore, on the basis of performance in the interview coupled with the weight-age in respect of academic merit, experience and other related parameters, the **Merit** of the candidates who appeared in the interview is enclosed as "**Annexure-A**" to this Notification.

Consequent upon the above, the **Select List** of the candidates against the available posts is given in “**Annexure-B**” to this Notice.

Note: The Commission reserves the right to have certificate/documents of the candidate verified, if it is at any stage found expedient to do so. The Select List is provisional and is subject to the outcome of writ petitions pending before any competent Court of law.
