Whereas, the Housing and Urban Development Department referred two posts (OM:01, RBA:01) of Assistant Architect to the Public Service Commission for being filled up from amongst the suitable candidates; and


Whereas, the Commission notified these posts, vide Notification No. 10-PSC of 2009 dated 19.03.2009 ; and

Whereas, in response to the above notification, 25 applications were received; and

Whereas, the interviews of the shortlisted candidates were conducted on 15.10.2010 with the assistance of experts from outside the state; and

Whereas, the result could not be finalized immediately after conclusion of the selection process as the Hon'ble High Court had directed against finalization of selection process in SWP No. 286/2008- IA No. 2151/2010, tilted Mushtaq Ahmad Khan and Anr V/s State & Ors. SWP No. 628/2016 & MP No. 1/2016, titled Devinder Gupta & Ors V/s State & Ors and SWP No. 640/2016, CMP No. 07/2016, titled Shahid Nabi Dar V/s State and Ors. The Hon'ble Court has now modified the interim directions and directed the Commission to finalize the selection process vide order dated 21.09.2017.

Whereas, in compliance to Hon'ble court directions, the Commission approves to declare the result and also issuance of the select list.

 Now, therefore, on the basis of the performance in the interview coupled with the weight-age in respect of academic merit, experience and other related parameters, the following two candidates have been selected for the post of Assistant Architect:-
