Subject: Unfair means case framed during Excise & Commercial Taxes Part-I (Departmental Examination), Session September, 2013, of Sh. Riaz Ahmad Dev S/o Kh. Mohad Shafi Dev.

Whereas, the J&K Public Service Commission vide notification No.PSC/EXAM/2013/56 dated: 24.06.2013 invited applications from eligible candidates, desirous for appearing in Excise & Commercial Taxes Part-I, Departmental examination in terms of Govt. Order No. 249 of 1960 Dated: 24/10/1960 and J&K Public Service Commission (Conduct of Examination) Rules 2005; and

Whereas, among others you also submitted your application form for appearing in the above said examination, consequently, Roll No. 40 was allotted to you; and

Whereas, the Excise & Commercial Taxes Part-I, Departmental Examination was held w.e.f 09.09.2013 to 11.09.2013 at Public Service Commission Office Complex, Resham Ghar Colony, Bakhshi Nagar Jammu and Govt. Amar Singh College, Gogji Bagh, Srinagar; and

Whereas, on the first day of commencement of examination and on all subsequent days of examination, prior warnings were issued by the supervisors against resorting to any type of unfairmeans covered in J&K Public Service Commission (Conduct of Examination) Rules 2005; and

Whereas, on scrutiny it was found that the candidate had made an appeal to the Evaluator on the answer script of Paper-B at Page No. 25 held on 10.09.2013; and

Whereas the action of the candidate falls within the definition of unfair means under Rule 20 of J&K Public Service Commission (Conduct of Examination) Rules, 2005; and

Whereas, you are prima facie guilty of resorting to unfairmeans and is liable for punishment under Rule 25 of J&K Public Service Commission (Conduct of Examination) Rules, 2005.

Now, therefore, before imposing appropriate punishment under rules upon you, you are directed to Show Cause within 10 days from the date of issuance of this notice as to why action in terms of above quoted rule be not taken against you. Failure to show cause within the stipulated time, action as warranted under law shall follow, without any further notice.

However, in case you wants to appear in person or wants to produce any evidence or record your statement, you may appear before the Secretary & Controller of Examinations, J&K Public Service Commission, Resham Grah Colony, Bakshi Nagar, Jammu on 16.11.2013 at 11:00 A.M for the purpose.
