Subject: Recruitment for the post of Scientific Assistant in Ecology, Environment & Remote Sensing (Forest Department)

Notice Dated: 26 -08- 2015

Whereas, the Forest Department vide their communication No. FST/Coord/44/2010 dated 10.03.2014 have referred three (3) posts of Scientific Assistants in Ecology, Environment & Remote Sensing Department to the Jammu and Kashmir Public Service Commission for filling up from amongst the eligible/ suitable candidates; and

whereas, the breakup of the above said posts as conveyed by the said Department is given as under:-

whereas, the Jammu and Kashmir Public Service Commission in pursuance of the reference of vacancies by the Forest Department, vide Notification No. 14-PSC (DR-P) of 2014 dated 20.06.2014, invited applications on prescribed format from the permanent residents of Jammu and Kashmir possessing the prescribed qualification, age; and

whereas, in response to the above said Notification, the Commission has received 207 application forms for these posts; and

whereas, these applications were scrutinized; and

whereas, in terms of rule 40(b) of the Jammu and Kashmir Public Service Commission(Business & Procedure) Rules,1980, shortlisting of candidates is done in the ratio of 1:5 for 1 to 5 posts on the basis of percentage of marks obtained in the basic prescribed qualification and weight- age to be given to higher qualification; and

whereas, vide notice dated 26.11.2014, as per short-listing criteria, 15 candidates were requested to furnish their requisite/deficient documents & in response thereto 12 candidates have furnished their deficient documents; and

whereas, the following three candidates have not furnished their deficient documents till date:-

The above shortlisted candidates are therefore again advised to submit their deficient documents as indicated against their name in the Office of Jammu and Kashmir Public Service Commission, Solina, Srinagar within ten (**10**) days from the date of issuance of this notice, failing which their candidature shall stand rejected without any further notice; and

whereas, two candidates namely Shri Navneet Sharma (OM) and Shri Shiv Kumar (SC) have submitted their degrees in M.Sc Agro Forestry and M.Sc(Hons) Zoology respectively.

whereas, the matter with regard to their eligibility was examined and it was found that the Recruitment Rules do not provide for any kind of equivalence as such, their candidature is hereby rejected.

whereas, with the rejection of the candidature of above two candidates it has been found that Shazia Ramzan under Open merit category & Vimal under SC category are falling next in merit (as per shortlisting criteria).

The candidates who did not make the grade may represent before the Commission within 10 (**ten**) days positively with the documents in support of their claim, if any, of being eligible for the post.
