**Subject: Interviews for the post of Assistant Professors in different disciplines-
Revised Notification SET-2013.**

NOTICE **Dated: 07 .01.2016**

Whereas, the Coordinator, J&K SET, University of Kashmir, Srinagar vide communication No.F(Eligible PSC/SET Cell) KU/15 dated 16.11.2015 addressed to the Secretary, J&K Public Service Commission conveyed that J&K SLET, 2013 Examination was conducted on 1st September, 2013 & the result thereof declared on 20th of December, 2013

whereas, the *bona fide* certificates were issued to the qualified candidates on different dates only after the verification of their documents; and

whereas, some of the candidates who had not been declared successful sought review of the SLET results on the basis of genuine keys which had resulted in issuance of supplementary Notification No. F(Revised Result SET-2013) SET/KU/15 dated 03.09.2015 in accordance with UGC Redressal Memorandum

whereas, all these candidates have been deemed to have qualified J&K SET, 2013 on 20.12.2013, or the date of qualification of their PG examinations whichever is later; and

whereas, on the basis of the above communication, some candidates approached the Hon'ble High Court through a medium of writ Petition SWP No. 3282/2015, MP No. 01/2015 titled Atiya Noor & Others V/s State and others of with the prayer to direct the Public Service Commission to entertain their application forms as they were not in position to fill up the forms in the absence of SET certificate the cut off date for reason attribute to J&K SET authorities; and

whereas, the Hon'ble High Court vide its order dated:-18-12-2015 directed as under;

"Meanwhile, respondents shall entertain the applications of the petitioners for the post of Assistant Professors for which applications have been invited in terms of Notification No. 12-PSC(DR-P) of 2013 dated 23.05.2013 in light of the communication addressed to the J&K Public Service Commission by the Coordinator, J&K SET, University of Kashmir, Srinagar under No.F(Eligible PSC/SET Cell) KU/15 dated 16.11.2015, the below mentioned candidates approached before the Hon'ble High Court with the prayer to entertain their applications for the post of Assistant Professors; and

whereas, the Commission has received a joint representation of SLET qualifiers of 2013 with the prayer that they are also similarly circumstanced and as such, may be given similar treatment; and

whereas, the Commission in its extra ordinary meeting held on 06.01.2016 decided that in order to provide justice to all similarly situated candidates, it would be fair to invite all such candidates to appear in the interviews at their own risk and

responsibility and the results shall not be declared till the final outcome of the writ petition No. 3282/2015 titled Atiya Noor & others v/s State and others.

Now, therefore, in view of the Commission decision taken in the extra ordinary meeting held today on 06.01.2015, all such candidates who have been declared to have qualified their SET on 20.12.2013 are deemed to have qualified set by virtue of Revised Notification dated:-03.09.2015 are informed through the medium of the Notice to submit their application along with the documentary proof of having qualified NET in 2013 together with other documents to participate in the interview process in their respective subjects as & when the interview schedule in their case is notified provided they were otherwise eligible on the cutoff date i.e 02.07.2014. In case of the candidates having qualified SET in 2013 in the subject of English, Mathematics & Physics for which the interview schedule has already been announced, they are informed to submit the requisite documents in the office of J&K PSC complex Resham Garh Colony Jammu by or before 2.00 p.m of 8th January, 2015 in person so that they are interviewed as per the following schedule:-

1. Mathematics	09.01.2015
2. Physics	09.01.2015
3. English/Functional English /English Literature	10.01.2015
