Whereas, the J&K Public Service Commission, vide Notification **No.10-PSC (DR-P) of 2017 dated 27.10.2017** invited online applications on prescribed format from the permanent residents of Jammu & Kashmir possessing the prescribed qualification for the 10 **posts (OM: 05, RBA: 01, SC:01, ST: 02 & ALC: 01)** of Assistant Professor **Geology** in Higher Education Department and in response to the above said Notification, the Commission received **134** applications in the said discipline; and

Whereas, the verification/ scrutiny of the documents was conducted by the Screening Committee constituted for the purpose and the documents of some candidates were found deficient and accordingly the deficiency notice was issued vide Notice dated 26.03.2019; and

Whereas, the deficient documents were received from the candidates in response to notice dated 26.03.2019 and the said documents were again verified/scrutinized by the Screening Committee for short listing of the candidates for interview; and

Whereas, the short listing of the candidates was conducted as per provisions of **Rule 51 of J&K Public Service Commission (Business and Procedure) Rules, 1980** as amended from time to time, which provides for weightage to be given to the Academic performance, outreach and extra – curricular activities, special attributes and teaching skills constituting total **57 points, (on pro-rata basis up to PG Level)** with the break-up tabulated as under:

3. Only eligible candidates possessing requisite qualification prescribed under rules shall be allowed to appear in the interview subject to the condition that they are within the prescribed age limit on the cut of date.
4. The candidates shall produce their original certificates/testimonials on the date of interview.
5. The candidature of Sh. Varinder Singh S/o. Balwan Singh under ALC Category is rejected on the grounds of non-submission of the requisite documents as notified vide notice dated 26.03.2019.
6. The candidature of all the candidates having Post Graduation in Applied Geology is also rejected on the grounds of non-possession of requisite qualification for the post of Assistant Professor Geology.
