Whereas, the Jammu & Kashmir Public Service Commission vide Notification No.10-PSC (DR-P) of 2017 date 27.10.2017 invited online application forms, on prescribed format, from the permanent residents of Jammu & Kashmir for the 10 posts of Assistant Professor, Bio-resource in Higher Education Department.

Whereas, the cut off merit under various categories alongwith the names of the eligible candidates was notified vide Notice dated 23.07.2021 with the stipulation that, if any candidate feels aggrieved with respect to the cut off merit and non-inclusion in the eligibility list, he/she may represent before the Commission within 10 days from the date of issuance of this Notice; and

Whereas, the representation submitted by the above candidates were scrutinized and examined in the Commission and the decision taken therein is indicated against each:-

S. No.	Name of the candidate	Remarks
1.	Fayaz Ahmad Dar	The candidate has done Ph.D degree in 2021 i.e. after cut-off date which is 31-12-2017. Hence, the representation is rejected.
2.	Bilal Ahmad Wani	The candidate has done his Master's degree in Botany. As per the decision of the Equivalence Committee furnished by the Higher Education Department the Master's degree in Botany is not equivalent to

		Master's degree in Bio-Resource. Hence, the representation is rejected.
3.	Nisar Ahmad Wani	The representation of the candidate which he had submitted in compliance to CAT Order, has already been considered and found devoid of any merit and accordingly, the claim has been rejected, vide consideration order dated 15.07.2021.
