Subject: Revised shortlisting notice/cut of merit for the post of Assistant Professor (Chemistry) in Higher Education Department.

**NOTICE
Dated: 21.10.2016**

Whereas, vide Notice dated 26.08.2016, shortlist/rejection/deficiency notice of candidates for the post of Assistant Professor (Chemistry) in Higher Education Department was issued; and

Whereas, it was also notified that the candidates who have also applied for the said post and do not fall in the short-listing /interview schedule criteria may represent before the Commission within fifteen days from the date of issue of this notice with sufficient proof of having higher or equal merit than the candidates shortlisted for interview. Besides, the candidates whose candidature has been rejected may also represent before the Commission within fifteen days with sufficient proof, if any, of having requisite qualification prescribed for the post; and

Whereas, the following candidates have submitted a representations alongwith proof of having eligible and having higher merit than the last shortlisted candidates for the posts of Assistant Professor (Chemistry); and

Whereas, after fresh scrutiny of the documents of these candidates it has been found that Shri Syed Raashid Maqsood and, Shri Vinayak Sharma is possessing **64.02** and **61.09** points respectively; and

Whereas, Kunzang Dolma (ST) is also provisionally found eligible for the post of Assistant Professor (Chemistry); and

Whereas, in the shortlisting notice dated 26.08.2016, Shri Bilal Ahmad Dar and Mehnaz Mehraj Damnoo who were possessing only 60.22 points respectively were shortlisted under Open Merit category; and

Whereas, after a fresh scrutiny of the requisite documents it has been found that Shri Nissar Ahmad Malik S/o Shri Mohammad Malik who was figuring at Sr.No. 108 in the shortlisting notice, does not possess the requisite prescribed qualification for the post on the cut off date; and

Whereas, the revised cut of merit under Open Merit category is now fixed as **60.37** points.

Now therefore, as per the revised cut of merit as also fresh scrutiny of the documents, the candidates namely Bilal Ahmad Dar and Mehnaz Mehraj Damnoo figuring at Sr.No. 138 & 139 in the shortlisted notice dated 26.08.2016 under Open Merit category do not fall within the shortlisted criteria and are hereby excluded from the short-listing notice including Shri Nissar Ahmad Malik S/o Shri Mohammad Malik whose candidature is rejected as he does not possess the requisite qualification on the cut of date and candidates namely Syed Raashid Maqsood S/o Syed Maqsood Ahmad, Vinayak Sharma S/o Shri Sant Kumar who are possessing **64.02 & 61.09** points respectively under Open merit category and also Kunzang Dolma under ST category are hereby shortlisted for the post of Assistant Professor (Chemistry).

However, Kunzang Dolma shall be allowed to appear in the interview process subject to the condition that she shall submit all the requisite documents in the Commission office on 26.11.2016.

The other terms and conditions as notified vide notice dated 26.08.2016 shall remain same.
