Whereas, the Health and Medical Education Department vide communication No. HME/HRM/80/2013 dated 24-03-2014, among others, referred 33 posts (OM = 20, RBA=06, SC= 02, ST = 03, ALC =01 and SLC= 01) of Consultant in the discipline of Anesthesiology to the J&K Public Service Commission for being filled up through direct recruitment from amongst the eligible/suitable candidates;

whereas, the said posts were notified by the Public Service Commission vide notification No. 13-PSC(DR-P) of 2014 dated 20-06-2014, however in the said notification, after the selection process was completed, 11 posts (RBA =04, SC = 02, ST = 03, ALC= 01 and SLC =01) of Consultant Anesthesiology remained unfilled;

whereas, the J&K Public Service Commission, vide Notification No. PSC/DR/2016/01 dated 04-02-2016, among other posts, notified these 11 posts and invited online applications on prescribed format from the permanent residents of Jammu & Kashmir possessing the prescribed qualification;

whereas, in response to the above said notification, the Commission received 08 applications in the said discipline; and

whereas, after scrutiny of the application forms, it has been found that the following candidates are provisionally eligible for the post of Consultant (Anesthesiology) subject to making good the deficiencies as indicated against each:-
