Whereas, the Health and Medical Education Department vide communication No. HME/HRM/80/2013 dated 24-03-2014, among others, referred 26 posts (OM=15, RBA = 05, SC= 02, ST = 03 and ALC =01)) of Consultant in the discipline of Paediatrics to the J&K Public Service Commission for being filled up through direct recruitment from amongst the eligible/suitable candidates;
