It is for the information of all the concerned candidates that the Screening Test for the posts of Assistant Controller (CAPD), shall be held on 09.12.2012 (Sunday) as already notified/reiterated from time to time.

The Admit Cards have already been dispatched to the candidates. However, they may also download the same from the Commission's website [www.jkpsc.nic.in](http://www.jkpsc.nic.in).

The eligible candidates who, fail to receive the Admit Cards or are not able to download the same, may approach the Commission office at Srinagar/Jammu on **07.12.2012** upto **04:00 PM**, where the Admit Cards shall be provided to such eligible candidates free of charges.

The following instructions are reiterated for the strict compliance by the candidates:

1. The candidate reports to the examination centre atleast half an hour before the commencement of examination.
2. No candidate shall be allowed to enter Examination Hall after 10 minutes of the commencement of examination.
3. No candidate shall be allowed to leave the Examination Hall until the expiry of full time.
4. **The candidate should use only blue/black ball point pen for marking the ovals in the OMR response sheet.**
5. Only one oval is to be darkened. If the candidates darken more than one oval the answer will be treated as wrong.
6. Any stray mark(s) recorded by the candidate on the answer sheet shall be treated as unfair-means.
7. No candidate shall bring Mobile Phone or any other electronic gadget within the premises of examination centre.

8. In case any candidate feels that any discrepancy existing in the test booklet in any question (s) or the Responses, a written representation explaining the details of such alleged discrepancy, be submitted within three days, indicating the Question No. (s) and the Test Booklet Series, in which the discrepancy is alleged. Representation not received within time shall not be entertained at all.

Apart from above the candidates should go through all instructions given in the response sheet carefully.
