- iii. Only eligible candidates, possessing requisite qualification prescribed under rules, shall be allowed to appear in the Oral Test/Viva-Voce subject also to the condition that they are within the prescribed age limit on the cut-off date.
- iv. The candidates, who have been declared to have qualified the Written Test, are advised to submit hard copy of their online application form along with the fee receipt at J&K PSC office, Solina, Srinagar/Resham Ghar Colony, Bakshi Nagar, Jammu or send the same to the address of the Controller of Examinations, J&K Public Service Commission, Solina Rambagh, Srinagar, by registered post. Only such identified documents as have been posted by or before 07.08.2018 and delivered in the Commission shall be considered.
- v. Candidates possessing Degrees obtained through Distance Mode shall be allowed to appear before the Interview Board subject to their satisfying the conditionalities prescribed under Government Order No. 252-HE of 2012 dated: 30.05.2012 & production of the documentary evidence in this regard.
- vi. The candidates shall produce their original certificates/testimonials on the date of oral test/Viva-Voce.


