- ii. (a) "M.A/M.Sc in Psychology with M.Phil in Clinical Psychology" or "M.A/M.Sc in Psychology with a clinical Psychologist certification duly recognised by MCI" instead of "MD Paediatrics duly recognised by MCI". Desirable qualification: "Ph.D in Clinical Psychology."
 - (b) "having atleast two years experience in Child and Adolescent Mental Health in a teaching institution recognised by the MCI or University of Kashmir/Jammu/SKIMS instead of "having minimum 3 vears teaching/research of experience as Registrar/Tutor, Demonstrator/Tutor or Resident in a recognised teaching medical Institution recognised by the MCI or University Kashmir/Jammu".
- iii. "MBBS" **instead of** "MBBS/MD" in minimum qualification against the post of Lady Medical Officer.
- iv. "M.Sc" **instead of** "B.Sc/M.Sc" in minimum qualification against the post of "Medical Record Officer".

v. "MD in PSM" **instead of** "MBBS/MD" in 'minimum qualification' against the post of Epidemiologist-cum-Assistant Professor (Lecturer)".
