Whereas, vide Notification No. 01-PSC(DR-P) of 2018 dated 17.01.2018, online application forms were invited on prescribed format from permanent Resident of J&K possessing prescribed qualifications for filling up of vacancies of Assistant Professor (Lecturer) Bio-Chemistry in the category of OM=01 each in Five Medical Colleges in Anantnag, Baramulla , Doda , Kathua and Rajouri in the Health and Medical Education Department through Direct Recruitment ; and,

Whereas, in response to the said notification, the Commission received 46 application including one under directions of the Hon'ble High Court, in the said discipline. After scrutiny of the application forms, the provisional eligibility of the candidates who applied for the posts of Assistant Professor (Lecturer) Bio-Chemistry in Government Medical College Anantnag , Baramulla , Doda, Kathua and Rajouri, was notified vide notice dated 31.08.2018 and out of 46 candidates, 23 candidates who were found provisionally eligible were advised to submit their deficient document. However the candidature of 20 candidates was rejected on the plea that they have not been possessing the requisite teaching experience or have not submitted hard copies with all documents; and,

Whereas, the candidates whose candidature was rejected were advised to represent before the Commission within weeks' time alongwith documents in support of their claim, if any, of being eligible for the post; and,

In response to the notice dated 31.08.2018, various representations & Complaints have been received by the J&K Pubic Service Commission, Srinagar. These representations & Complaints were examined and disposed of by the Appellate Authority constituted for the purpose. Accordingly an interview notice dated 15.09.2018 was issued wherein 19 candidates have been found eligible to be called for interview who have applied in response to the notification No. 01-PSC(DR-P) of 2018 dated 17.01.2018. Besides, it was also advised in the interview notice that the candidates who have been shown in the deficiency notice dated 31.08.2018 and now have not been called for interview may visit the office of Secretary on 17.09.2018 alongwith requisite documents viz qualification and experience certificates duly authenticated for further clarification; and



In response to the interview Notice dated 15.09.2018, the Commission received the applications of the following candidates:-

Now therefore, the Appellate Authority after scrutinizing of the application form of the above 9 candidates only one candidate namely Dr. Ashaq Ullah Bhat, Application No. 18010105600029 was found eligible for appearing in the interview alongwith the 19 candidates whose notice already stand issued on 15.09.2018. The applications of remaining 8 found devoid of any merit, hence were rejected.
