Subject:- Declaration of result for the posts of Lecturer Orthopedics (GMC Jammu/Srinagar) in Health and Medical Education Department.

Whereas, the Health & Medical Education Department vide letter No. ME /Gaz-187 /2014 dated 11.04.2017 referred 01 post under OM Category of Lecturer Orthopedics, to the Public Service Commission for being filled up from amongst the suitable candidates in Govt. Medical College ,Jammu; and ,

Whereas, J&K Public Service Commission advertised the posts among with other posts vide Notification Nos. 04-PSC (DR-P) of 2016 dated 18.02.2016 and ,

Whereas the candidature of 15 applicants received in response to the Notification No. 04-PSC (DR-P) of 2016 dated 18.02.2016 against the post in GMC Jammu was found eligible and called for interview; and

Whereas, interview was conducted at J&K Public Service Commission, Resham Ghar Colony, Bakshi Nagar , Jammu w.e.f 19.04.2018 to 21.04.2018 with the assistance of Experts from outside the state; and,

Whereas, on the basis of the overall performance in the interview and in pursuance of Rule 51 of the J&K Public Service Commission ( Business & Procedure) Rules, 1980, as amended from time to time and other related parameters, selection list was issued vide Notification No. 22-PSC (DR-S) of 2018 dated 26.04.2018; and ,

Whereas due to oversight, one candidate namely Dr.Kanav Padha has erroneously been shown to have secured 65.82 points against notifications . 04-PSC (DR-P) of 2016 dated 18.02.2016 ; and,

Whereas, as per the selection list notified vide notification No. 22-PSC (DR-P) of 2018 dated 26.04.2018, total marks secured by Dr.Kanav Padha is **65.57** against the notification 04-PSC (DR-P) of 2016 dated 18.02.2016. He has



erroneously been shown to have obtained 0.50 points instead of 0.25 points for the experience and the same needs to be rectified; and,

Whereas on the basis of overall performance of the said candidate, in the interview coupled with the weightage in respect of academic merit, experience and other related parameters for the post of Lecturer Orthopedics (GMC Jammu) in Health Medical Education Department and as per selection record the candidate has secured 65.57 points instead of 65.82 points for post notified under Notification 04-PSC (DR-P) of 2016 dated 18.02.2016 ; and

Now, therefore, on the basis of the record, in case of Dr.Kanav Padha, the points awarded on account of experience have been rectified and calculated as 0.25 instead of 0.50. He in no case falls in the selection zone as the last cut of merit under OM category is 69.57.
