Whereas, in response four candidates among others who were not eligible being overaged approached the Hon'ble Court and the Hon'ble High Court passed the order dated:3rd August 2018, the operative part whereof reads as under:-

"Meanwhile, we direct that the respondents Commission shall receive the offline applications forms of the petitioners. It is however, made clear that mere receipt of the application forms, as aforesaid, shall not confer any right on the petitioners to claim participation in the selection process, which shall be subject to the outcome of this appeal".

Whereas, the Commission received the offline application forms of the these four candidates purely on the directions of the Hon'ble High court, which do not confer any right on the petitioners to claim participation in the selection process; and



Whereas the upper age limit in accordance with the J&K Civil Services (Judicial) recruitment rules, 1967 under SRO-5 dated: 4th January 1968 Rule 7 is prescribed as under:-

No person shall be recruited to the Service who is more than 35 years of age on the first day of January of the year in which the advertisement notice for the posts of Munsiffs is issued and

Whereas, no further direction in this regard has been received from the Hon'ble Court therefore the candidature of the following four candidates is hereby rejected for the reason elucidated herein above.
