Whereas, vide Notification No. 18-PSC (DR-P) of 2016 dated 13.12.2016, online applications were invited from eligible candidates for the post of Physical Training Instructor in Higher Education Department.

Whereas, on the scrutiny of the 306 application forms 156 candidates have been found eligible for **Walking Test** to be held on **15.05.2018 (Tuesday)** at Jammu University Athletic Track in respect of the candidates hailing from Jammu division and at University of Kashmir, Sports Complex, Hazratbal, Srinagar in respect of candidates hailing from Kashmir division;

Whereas, the Commission has received representations from the following five female candidates who have applied for the post of Physical Training Instructor in Higher Education Department and have been found eligible for Physical Fitness Test for exemption of Physical Fitness Test due to their advanced stage of pregnancy:-

Whereas, the matter was placed before the Commission. The commission has decided that the above mentioned candidates shall be admitted to written test/ interviews if otherwise eligible and shortlisted subject to their appearance to the Physical Test at a later stage and depending upon their performance and placement in the merit list.

In view of the above decision, above candidates shall not appear before the Physical Fitness Test Board on **15.05.2018**. A decision shall be taken accordingly about the date and timings for the Physical Fitness Test/Walking test.
