Whereas, pursuant to the indent of the Higher Education Department, **06 posts [OM:03, RBA:01, SC:01 & ST:01] of Assistant Professor** in the discipline of **Food Science Technology** were advertised vide notification No. 12-PSC (DR-P) of 2014 dated 29.05.2014 for inviting applications from the candidates possessing the prescribed academic qualification; and

Whereas, the notification ibid was issued in supersession of the earlier notification, inter-alia mentioning that the candidates who had already applied in response to the earlier notification need not apply subject, however, to fulfillment of the requirements laid down in SRO 124 dated:21.04.2014; and

Whereas, in response, 79 candidates submitted their applications, which were scrutinized for determining their eligibility in accordance with the J&K Public Service Commission (Business & Procedure) Rules, 1980; and

Whereas, following criteria has been adopted for purposes of calculation of the merit of the candidates:

Whereas, the cut off merit under **OM & RBA** category works out as **66.48** and **66.38** respectively. Only one candidate has been found to be eligible under SC Category obviating thereby the need to determine the cutoff merit under the said category; and
