With a view to further upgrading E – Technology and making systems more candidate friendly, the Jammu and Kashmir Public Service Commission has, in principle, decided to invite **Online Applications** for various posts advertised by it from time to time, from a date as may be specified in advance in this regard. The Commission has been examining various aspects of the **Online Application System** and detailed deliberations have been held with various organisations to work out modalities on the Subject. With the shifting to online method, no Application shall be received offline. Every candidate shall be required to fill in the Application Form Online and deposit the fee also as per the mode as may be prescribed in this connection by the Commission.

With the commencement of the receipt of **Online Application Forms**, the candidates will not be required to deposit the Application Forms in the Commission office either through person or through post. With the shifting to receipt of **Online Application Forms**, the candidates will be able to ascertain their eligibility, acceptance/rejection of their Application Forms and download their admit cards etc in an improvised manner and much faster than the existing system.

To reiterate, after notification of the date for receipt of **Online Applications**, no offline Application Form shall be accepted by the Commission. In due course of time the Commission would aim at conducting online examinations as far as possible/practicable.
