Whereas, vide this Commission's Notification No. 34-PSC(DR-S) of 2016 dated 28.11.2016, the selection list for the posts of Assistant Professor (Philosophy) was notified; and

Whereas the selection against one post under RBA category at Sr.No. 1 was kept withheld on the ground that prospective selectee their against had been called for interview on the basis of her being a Ph.D degree holder as well as NET qualified as she meanwhile submitted an application maintaining thereunder that she has also qualified NET and therefore, on the basis of decision of the Commission in respect of such candidates as have been declared to have qualified NET retrospectively but were not NET certificate holders before the cut off date but allowed them to appear in interview on the analogy of interim orders passed in case titled Atiya Noor & Others Vs State & Ors, merits consideration accordingly.

And whereas Ms. Kainat has now made a representation mentioning there that her candidature may be considered on the basis of her Ph.d, being in accordance with UGC Guidelines 2009 read with UGC guidelines of 2016 supported by MSP thereof from Aligarh Muslim University independent to the outcome of writ petition mentioned above regarding validity of NET certificates issued after cut off date.

Whereas, on the basis of performance in the interview coupled with weight-age in respect of the academic merit, experience and other related parameters, she scored 60.07 points and is falling within the selection zone and;

Whereas, as per her merit position she is figuring at Sr.No.1 in the selection list under RBA category; and

Whereas, it was found that if NET certificate submitted by the candidate in pursuance of Commission Notice dated 7.11.2016, on the analogy of Atiya Noor Vs State & Ors, is not considered and 5 points awarded for higher qualification i.e Ph.d withdrawn as it has become her eligibility even then she is figuring at Sr.No. 1 under RBA category by scoring higher merit i.e 55.07 points.

Consequent upon the above, the select list against the available post under RBA category against which the result was kept withheld is hereby released as under:-
