Whereas, interview schedule for the post of Assistant Professor, Information Technology in Higher Education Department has been notified vide notice dated 16.08.2018;

whereas, the Hon'ble High Court vide orders dated 14.08.2018 and 24.08.2018 in Writ Petition SWP No. 1915/2018 IA No. 01/2018 titled Junaid and another Vs. State of J&K and Others and OWP No. 1562/18 MP No. 01/2018 titled Syed Mohsin Saif & Ors Vs J&K PSC has been directed as under:-

**OWP No. 1562/18 MP No. 01/2018**

*"Notice in MP also, returnable within the same period. Meanwhile subject to objections respondents are directed to provide fresh application forms to the petitioners and also conduct their interview for the post of Assistant Professor in the discipline of Information Technology which is rescheduled to be held on 28<sup>th</sup> & 29<sup>th</sup> of August, 2018.
