Subject:- Filling of the posts of Horticulture Development Officer in Agriculture and Production Department.

Where as vide this office Notification No. 10-PSC(DR-P) of 2013 dated: 20.06.2013, 22 posts of Horticulture Development Officer in Agriculture and Production Department were notified with the following breakup:-

OM: 17, RBA: 02, SC: 01, ST: 01 Total: 22 and

Whereas as per the recruitment rules of Agriculture Production Department notified vide SRO No. 161 dt: 23.09.2002, the prescribed qualification for the post of Horticulture Development Officer is as under:-

“M.Sc Horticulture. In case non availability B.SC Horticulture/B.Sc Agriculture”, and

Whereas in response to the said notifications, 266 application forms were received; and

Whereas after verification of documents submitted by the candidates it has been found that some candidates do not possess the M.Sc Horticulture/M.Sc Agriculture(Horticulture) Degree; and

Whereas some candidates are lack of other eligible requirements; and

Whereas there are sufficient number of candidates available possessing qualification of M.Sc Horticulture/M.Sc Agriculture(Horticulture);and

Whereas it has been decided to call only those candidates for interview to the post of Horticulture Development Officer who possesses M.Sc Horticulture/M.Sc Agriculture(Horticulture) Degree from the recognized universities, in view of the sufficient No. of candidates available with such qualifications and also full filling other eligibility requirements;

Now, therefore the candidature of below mentioned candidates who had applied for the posts of Horticulture Development Officer in Agriculture Production Department against the Commission's Notification No: 10-PSC(DR-P) of 2013 dated: 20.06.2013 22 is hereby rejected for the reasons as shown against each candidate:-
