6. How have Government policies relating to Foreign Direct Investments in industries including banking and telecom sectors, affected the growth of business in recent years ? 60

7. (a) What are the assumptions and limitations of Linear Programming ?

(b) A firm manufactures two types of products, namely 'Ax' and 'By'. Both the products go through two technicians, first a Cutter and then a Finisher.

A unit of 'Ax' requires 2 hours Cutter's time and 2 hours of Finisher's time. A unit of 'By' requires one hour of Cutter's time and two hours of Finisher's time. The Cutter has 104 hours and the Finisher has 76 hours available time. Profit on one unit of 'Ax' is Rs. 6.00 and on one unit of 'By' is Rs. 11.00. Assuming that the manufacturer can sell all produced, how many of each type of products should be manufactured for best return ?
