Whereas, the J&K Public Service Commission, vide Notification No. 16-PSC (DR-P) of 2016 dated 10.08.2016, notified 01 post of Lecturer, Conservative/Operative Dentistry and invited online applications on prescribed format from the permanent residents of Jammu & Kashmir possessing the prescribed qualification;

Whereas, in response to the above said notification, the Commission received three (03) applications in the said discipline; and

Whereas, vide notice dated 06.09.2017 Dr. Ravinder Kumar Bhagat, Barcode No. 16011608400001, was advised to submit his deficient documents viz. 1) Date of birth Certificate, 2) Post Graduation Certificate, and 3) experience certificate; and

Whereas, while submitting documents, the above name candidate has produced teaching experience as Registrar in the discipline of Oral Surgery from 15.01.2008 to 21.04.2010 which is not relevant to the said post, as it has been acquired before passing out the Post Graduation i.e.11.10.2013.

Now therefore, in view of the above, the candidature of Mr. Ravinder Kumar Bhagat, for the post of Lecturer, Conservative/Operative Dentistry, who was called for interview on 12.12.2017 vide notice dated 22.11.2017, is hereby rejected.
