Subject: Unfair means case framed during Secretariat Assistant Course/Foundation Course Departmental Examination Session July-2013.

Whereas, the J&K Public Service Commission vide notification No. PSC/EXAM/2013/35 dated: 08.05.2013 invited applications for Secretariat Assistant Course/Foundation Course Departmental Examination; and

Whereas, among others you also submitted your application form for appearing in the above said examination, consequently, Roll No. 236 was allotted to you; and

Whereas, vide notification No. PSC/EXAM/2013/53 Dated: 18.06.2013, the Examination was held w.e.f 08.07.2013 to 15.07.2013 at Public Service Commission Office Complex, Resham Ghar Colony, Bakshi Nagar Jammu and Govt. S.P. Higher Secondary Institute, M.A. Road, Srinagar; and

Whereas, on the day of Examination and on subsequent days, prior warnings were issued by the supervisors against resorting to any type of unfair means covered in J&K Public Service Commission (Conduct of Examination) Rules 2005; and

Whereas, on scrutiny it was found that the candidate had made an appeal to the Evaluator on the answer script at Page No. 09 of paper V; and

Whereas the action of the candidate falls within the definition of unfair means under Rule 20 of J&K Public Service Commission (Conduct of Examination) Rules, 2005; and

Whereas, you are prima facie found guilty of resorting to unfair means and is liable to punishment under Rule 25 of J&K Public Service Commission (Conduct of Examination) Rules, 2005; and

Whereas the case was placed before the Controller of Examinations in terms of Rule 23 of the J&K Public Service Commission (Conduct of Examination) Rules, 2005 for consideration, who being satisfied that prima facie case of unfair means exists against you has decided to serve show cause notice upon you, as to why action under Rule, 25 of J&K Public Service Commission (Conduct of Examination) Rules, 2005 be not taken against you; and

Now, therefore, before imposing appropriate punishment under rules upon you, you are directed to Show Cause within 20 days from the date of issuance of this notice as to why action in terms of above quoted rule may not be taken against you. Failure to show cause within the stipulated time, action as warranted under rules shall follow, without any further notice.

However, in case you want to appear in person to produce any evidence or record your statement, you may appear before the Secretary & Controller of Examinations, J&K Public Service Commission, Resham Grah Colony, Bakshi Nagar, Jammu on 10.11.2013 at 11:00 A.M for the purpose.
