Whereas, the provisional select list for the posts of Medical Officers in Health & Medical Education Department was notified vide notification No. 01-PSC(DR-S) of 2014 dated 25.02.2014; and

Whereas one candidate Sh. Sandeep Gupta bearing Rollno.3303117 represented before the Commission on 28.04.2014 that he has applied under PHC Category and he has not been considered under PHC category. Upon re-examination of his Biodata it has been found that he is a PHC candidate and is eligible to be considered under PHC category but inadvertently his candidature was considered under Open Merit category as his PHC status was not reflected; and

Whereas, now his candidature has been considered under PHC category and in accordance with Reservation Rules for PHC Category he makes into the select list and as a result the last candidate in open merit has to be dislodged; and

Whereas, the last candidate selected in Open Merit is a RBA category Candidate, while dislodging him in OM Category he will figure at top of the RBA category and as a result the last candidate in the RBA category namely Mariya Habib bearing Rollno. 3301727 gets dislodged from the Select List of RBA category; and

Whereas, the Commission on 28.02.2014 considered the matter and accorded approval to rectification and the consequent change in the results notified earlier.
