Whereas, Health and Medical Education Department referred 01 post under Open Merit vide letter No. ME/Gaz-187/2014 dated 11.04.2017, 05 posts (OM=03, RBA=01 & ST=01) vide letter No. ME /Gaz-187/2014 dated 11.04.2017 and 08 posts of Lecturer (OM=07 and RBA=01) vide letter Nos. ME/Gaz-187/2014-I dated 11.04.2017 and No. ME/Gaz-154/2012 dated 15.06.2017 in the discipline of Obs. & Gynae (GMC-Jammu/Srinagar); and

Whereas, J&K Public Service Commission advertised these posts vide Notification No. 02-PSC DR-P) of 2017 dated 01.05.2017 and No. 05-PSC (DR-P) of 2017 dated 10.07.2017; and

Whereas, 30 and 43 applications were received vide Notification No. 02-PSC (DR-P) of 2017 dated 01.05.2017 fro GMC, Srinagar and Jammu respectively and 41 applications received for GMC, Srinagar vide Notification No. 05-PSC (DR-P) of 2017 dated 10.07.2017. Out of these, 29 candidates and 39 candidates under first notification and 38 applicants under second notification were found eligible and called for interview; and

Whereas, interview was conducted at J&K Public Service Commission, Solina, Srinagar w.e.f. 14.05.2018 to 16.05.2018 with the assistance of experts from out side the State; and

Whereas, on the basis of the overall performance in the interview and in pursuance of Rule 51 of the J&K Public Service Commission (Business & Procedure) Rules, 1980, as amended from time to time and other related parameters, selection list was issued vide notification No. 25-PSC (DR-S) of 2008 dated 21.05.2018; and

Whereas, due to oversight one candidate namely Dr. Shazia Ashraf Khan had secured **63.07** points but her name was not figuring in the select list issued vide notice dated 21.05.2018. To rectify this error a corrigendum to notification No. 25-PSC (DR-S) of 2018 dated 21.05.2018 has been issued and the name of Dr. Shazia Ashraf Khan has figured at Sr. No. 26 in the select list ; and

Whereas, a candidate namely Dr. Saima Sadiq who was not eligible under ST category against Notification No. 02 PSC of 2017 and was called for interview under court directions. The Hon'ble Court has directed not to declare her result. However, being eligible under OM category she has been called for interview against Notification No. 05-PSC of 2017 dated 10.07.2017 and there has no bar in declaring her result under this Notification but her result has not been declared under Notification No. 25 dated 21.05.2018 followed by corrigendum dated 21.05.2018 due to oversight.

Now, therefore, on the basis of overall performance of the said candidate, in the interview coupled with the weightage in respect of academic merit, experience and other related parameters for the post of Lecturer Obst. & Gynae (GMC, Srinagar) in Health Medical Education Department and as per selection

record the candidate has secured **60.40** points under Notification No. 05-PSC of 2017 dated 10.07.2017. She does not fall in the selection zone as the last cut of merit ~~is~~ under OM category is **61.85**.
