Whereas, the J&K Public Service Commission vide notification No.PSC/EXM-11/120 dated 04/10/2011 invited applications from eligible candidates desirous of appearing in Combined Competitive (Main) Examination 2011, in accordance with the provisions laid down in SRO 387 of 2008 and J&K Public Service Commission (Conduct of Examinations) Rules, 2005; and

Whereas, among others, the below mentioned candidates also submitted their application forms for appearing in the above said examination, consequently, Roll No's. 1201183, 0301171, 1900640, 0400487 & 2200374 were allotted to them; and

Whereas, the Combined Competitive (Main) Examination 2011, was held w.e.f. 15.02.2012 to 10.03.2012 at different centers at Jammu & Srinagar; and

Whereas, during the course of examination 05 unfair means cases were registered by the Supervisors of different centers; and

Whereas, the accused candidates were served with Show Cause notices through press and by post asking them to explain their position and, if they desire so, may appear in person before the Controller of Examinations J&K Public Service Commission in support of their cause; and

Whereas, all the 05 involved candidates preferred their replies to show cause notices served upon them and also one candidate recorded his statement before the Controller of Examinations; and

Whereas, the cases along with all allied material were placed before the Committee on Unfair means which after examining the seized incriminating material, Supervisors report and the explanations preferred by the accused candidates formulated recommendations in respect of each case for consideration and decision of the Commission; and

Whereas, after considering the cases in light of the recommendations of the Committee on Unfair means the Commission approved award of punishments to the involved candidates as shown in remarks column against each below:-
