Subject: SWP No. 1386/2017 titled Dr. Isha Slathia V/s State and Ors, Consideration of experience certificate of Isha Slathia-thereof.

- 1. Whereas, the Higher Education Department referred 64 posts (OM:36, RBA:13, SC:06, ALC:02 & SLC:01) of Assistant Professor, Zoology to Public Service Commission for being filled up from amongst the suitable candidates; and
- 2. Whereas, the Commission, notified these posts vide Notification No. 12-PSC (DR-P) of 2014 dated 29.05.2014 and in response 288 application forms and,173 eligible candidate were shortlisted for interview including the petitioner; and
- 3. Whereas, the selection list was issued vide Notification No. 13 PSC (DR-S) of 2017 dated 31.03.2017 and the petitioner who secured 57.98 marks was not falling in the selection zone as the last cut of merit under OM category was 60.15 points; and
- 4. Whereas, the petitioner filed SWP No. 1386/2017, MP No. 01/2017 before the Hon'ble High Court, Jammu, and the Hon'ble High Court disposed of the SWP vide order dated 04.12.2017 with the following directions:-

"This writ petition is disposed of with a direction to the respondent No. 2 to consider the experience certificate of the petitioner while assessing the final merit of the petitioner for the post in question in accordance with eligibility criteria in terms of the Advertisement notice. Let the aforesaid exercise be completed with a period of four weeks form the date of receipt of a certified copy of order passed to day."

5. Whereas, the petitioner submitted a representation before the Commission with the plea that her research as well as teaching experience certificate obtained from Secondary School was not considered at the time of interview.

- 6. Whereas, after scrutiny of the petitioners application form and the documents enclosed with it, it was revealed that candidate has not enclosed research certificate or Teaching experience certificate with the form and has also failed to produce the same at the time of interview; the teaching experience certificate on the basis of which the candidate is claiming assessing the merit has been issued on 12.07.2017 by Arvind Gosh Higher Secondary School & countersigned by Chief Education Officer, Samba on 14.07.2017, whileas the interview was conducted on 14-01-2016-16-01-2016.
- 7. Whereas, as per the circular instructions dated 14.03.2016, production of documents like publications, books, seminars, presentations, experience and other special attributes whatsoever, should not be entertained after the interview is over. Relevant part of the circular is quoted as under:-

In the above backdrop, it is hereby notified that in future, no document, what-so ever be entertained from any candidate, after the conclusion of the interview."

In view of the above explained position, the case of Dr. Isha Slathia was considered and her claim found to be devoid of any merit, and is hereby rejected.
