- 1. Whereas, the J&K Public Service Commission conducted the Written Test for the post of Medical Officer (Allopathic) in Health & Medical Education Department on 24.05.2022.and
- 2. Whereas, in pursuance of Rule 12B of the Jammu & Kashmir Public Service Commission (Conduct of Examination) Rules, 2005, as amended upto date, the Provisional Official Key was notified and uploaded on the official website of the Commission for information of the candidates on 24.05.2022, inter-alia notifying that, if any candidate feels that the key to any of the question/s is wrong/incorrect, he/she may prefer a representation/objection on the prescribed proforma to the Controller of Examinations within a period of three days from the date of its notification, i.e upto 27.05.2022 (12:00 Noon) along with documentary proof /evidence and the fee of Rs. 500/- per question; and
- 3. Whereas, in response to the said notification, number of representations were received by the J&K Public Service Commission; and
- 4. Whereas, all the objections/representations were referred to the Committee of Experts as envisaged in Rule 12B of the J&K Public Service Commission (Conduct of Examination) Rules, 2005, as amended from time to time, for Independent Expert opinion; and
- 5. Whereas, the independent team of Experts have recommended changes in the Provisional Official Key;

Now, therefore, in view of the above and on the basis of opinion of the independent team of Experts, it is hereby notified that:-

- a) The changes recommended by the Committee of Experts are hereby adopted and the Final Official Key is annexed as Annexure "A" to this notification. In terms of Rule 12 A (c) of the J&K Public Service Commission (Conduct of Examination) Rules, 2005 as amended upto date, the marks allocated to the deleted questions shall be individually added to the marks secured by the individual candidates to ensure that the marks allocated for the question paper as a whole remain unchanged, at the time of calculation/compilation of award sheet before the declaration of the result;
- b) The amount deposited @ Rs 500/- per question is also hereby released in respect of genuine/correct representations and same shall be transferred through RTGS in individual account of candidates.
