MEGztd-56/2022 dated 06.04.2022 and MEGZtd-21/2022 dated 07.07.2022, referred one (01) post under Open Merit Category of Lecturer Oral & Dental Pathology (IGGDC-Jammu), for selection of suitable candidate; and,

Whereas, the interview of the candidates, was conducted on 01.03.2023 with the assistance of experts; and,


Whereas, three candidates remained absent and did not participate in the interview.

Consequent upon the facts stated here-in-above, **Dr. Pradakhshana Vijay D/O Vijay Kumar Dhar R/O H.No.326N, Sector 2, Durga Nagar, Roop Nagar, Jammu having secured 76.50 points, is provisionally selected against the available post under Open Merit.**
