Whereas, Health & Medical Education Department, vide letter No. ME-GZtd/21/2022 dated: 10.03.2022, referred two (02) posts under Open Merit Category of Lecturer **Anesthesia/ICU** for State Cancer Institute at Super Specialty Hospital (GMC-Jammu), for selection of suitable candidates; and,

Whereas, the J&K Public Service Commission, vide Notification No. 12- PSC (DR-P) of 2022 dated: 13.05.2022, advertised the said post for selection of suitable candidate; and,

Whereas, the Commission received 29 applications, which were scrutinized and 26 candidates were called for interview; and,

Whereas, the interview of the candidates, was conducted on 08.03.2023 with the assistance of experts; and,

Whereas, six candidates remained absent and did not participate in the interview and two candidates were found ineligible.

Now, therefore, on the basis of the performance in the interview in pursuance of Rule 44 of the J&K Public Service Commission (Business & Procedure) Rules, 2021 and other related parameters, the merit of the candidates who have appeared in the interview is enclosed as **Annexure-"A"** to this Notification.


Consequent upon the facts stated here-in-above, the provisional **select list** against the available posts is given in **Annexure-B** to this Notification.


