 - 4. Whereas, both the objections/representations were referred to the Committees of Experts as envisaged in Rule 10 (d) of the J&K Public Service Commission (Conduct of Examination) Rules, 2022, as amended from time to time, for Independent Expert opinion; and
 - 5. Whereas, the independent team of Experts have recommended changes in the Provisional Official Keys in respect of the said paper;
