Whereas, Health & Medical Education Department, vide letter No. MEGztd/270/2022 dt: 01.11.2022 & MEGztd/246/2022 dt: 05.12.2022, referred four (04) posts (OM:04) of Assistant Professor (Psychiatry) one each in GMC-Handwara, GMC-Udhampur, GMC-Doda and GMC-Rajouri under Open Merit category, for selection; and,

Whereas, the J&K Public Service Commission, vide Notification No. 30- PSC (DR-P) OF 2022 dated: 30.12.2022 & 31- PSC (DR-P) OF 2022 dated: 30.12.2022, advertised the said posts for selection of suitable candidates; and,

Whereas, a written test was conducted on 25.05.2023. The result of the written test was declared vide Notification No. PSC/Exam(s)/2023/29 dated: 26.06.2023 in pursuance of Rule 42 of J&K Public Service Commission (Conduct of Examination) Rules, 2022 and Rule 31 of J&K Public Service Commission (Business & Procedure) Rules, 2021 as amended upto date. Ten candidates were called for interview; and,

Whereas, the viva-voce of candidates was conducted on 04.07.2023, with the assistance of Experts; and,


Whereas, two candidates remained absent and did not participate in the interview.
