Whereas, Health & Medical Education Department, vide letter No. MEGztd/270/2022 dt: 01.11.2022, referred two (02) posts (OM:02) of **Assistant Professor (Ophthalmology)** one each in **GMC-Handwara** and **GMC-Udhampur** under Open Merit category, for selection; and,

Whereas, the J&K Public Service Commission, vide Notification No. 30- PSC (DR-P) OF 2022 dated: 30.12.2022, advertised the said posts for selection of suitable candidates; and,

Whereas, a written test was conducted on 25.05.2023. The result of the written test was declared vide Notification No. PSC/Exam(s)/2023/29 dated: 26.06.2023 in pursuance of Rule 42 of J&K Public Service Commission (Conduct of Examination) Rules, 2022 and Rule 31 of J&K Public Service Commission (Business & Procedure) Rules, 2021 as amended upto date. Ten candidates were called for interview; and,


Whereas, the viva-voce of candidates was conducted on 04.07.2023, with the assistance of Experts.

Now, therefore, on the basis of the performance in the written test and interview in pursuance of Rule 44 (ii) of the J&K Public Service Commission (Business & Procedure) Rules, 2021 and other related parameters, the merit of the candidates who appeared in the interview is enclosed as **Annexure-"A"** to this Notification.

Consequent upon the above, the provisional select list of the candidates as per merit-cum-preference is given in Annexure-B to this Notification.




