Whereas, Health & Medical Education Department, vide letter No. MEGztd/270/2022 dt: 01.11.2022 & MEGztd/246/2022 dt: 05.12.2022, referred three (03) posts of Assistant Professor (**Forensic Medicine**) in GMC- Handwara, GMC- Udhampur and GMC- Rajouri under Open Merit category, for selection; and,

Whereas, the J&K Public Service Commission, vide Notification No. 30- PSC (DR-P) OF 2022 dated: 30.12.2022 & 31- PSC (DR-P) OF 2022 dated: 30.12.2022, advertised the said posts for selection of suitable candidates; and,

Whereas, a written test was conducted on 25.05.2023. The result of the written test was declared vide Notification No. PSC/Exam(s)/2023/29 dated: 26.06.2023 in pursuance of Rule 42 of J&K Public Service Commission (Conduct of Examination) Rules, 2022 and Rule 31 of J&K Public Service Commission (Business & Procedure) Rules, 2021 as amended upto date. Four candidates were called for interview; and,

Whereas, the viva-voce of candidates was conducted on 06.07.2023, with the assistance of Expert.

Now, therefore, on the basis of the performance in the written test and interview in pursuance of Rule 44 (ii) of the J&K Public Service Commission (Business & Procedure) Rules, 2021 and other related parameters, the merit of the candidates who appeared in the interview is enclosed as **Annexure-"A"** to this Notification.

Consequent upon the above, the provisional select list of the candidates as per merit-cum-preference is given in Annexure-B to this Notification.

1. The Commission reserves the right to have certificates/documents of the candidate verified, if at any later stage found expedient to do so. The Selection of the candidate is purely provisional and is subject to the outcome of writ petition(s) pending before any competent Court of law.
2. The selection is provisional and objections, if any, may be submitted to the Commission within five days for examination and disposal. No claim, whatsoever, shall be entertained after five days from the date of issuance of Notification.
3. The post in GMC Rajouri remained unfilled due to non-availability of candidate.


