
Whereas, the viva-voce of candidates was conducted on 07.07.2023, with the assistance of Experts.

3. Two posts, one each in GMC Handwara & GMC Doda, remained unfilled as none of the candidates crossed the benchmark as required under Rule 50 of J&K PSC (Business & Procedure) Rules,2021.




