Whereas, a written test was conducted on 25.05.2023. The result of the written test was declared vide Notification No. PSC/Exam(s)/2023/29 dated: 26.06.2023 in pursuance of Rule 42 of J&K Public Service Commission (Conduct of Examination) Rules, 2022 and Rule 31 of J&K Public Service Commission (Business & Procedure) Rules, 2021 as amended upto date. Eleven candidates were called for interview; and,

Whereas, the viva-voce of candidates was conducted on 06.07.2023, with the assistance of Experts; and,

Whereas, provisional select list was issued vide Notification No.35-PSC (DR-S) of 2023 Dated: 06.07.2023; and,

Whereas, upon scrutiny it was found that the post in GMC Baramulla in the provisional select list has been shown in OM category whileas the said post was

advertised under RBA category in the Notification No. 31- PSC (DR-P) OF 2022 dated: 30.12.2022; and,

Whereas, this has entailed a change in provisional select list in GMC Handwara as well as GMC Baramulla.


