Declaration of result in compliance to Hon'ble Central Administrative Tribunal order dated 06.02.2023, passed in MA No 39/2023, OA No. 1119/2023 titled Faheem Tahir Qureshi & ors vs UT & Ors.

NOTICE

Dated: 13-07-2023.

- 1. Whereas, the candidature of the applicants in the instant case was rejected for appearing in J&K Combined Competitive (Mains) Examination 2021, for want of a valid domicile certificate; and,
- 2. Whereas, the applicants were allowed to appear in the J&K Combined Competitive (Mains) Examination 2021, on the basis of the Hon'ble Central Administrative Tribunal direction dated 08.03.2022, passed in OA NO 144/2022, titled Faheem Tahir Qureshi & ors Vs UT. However, the Hon'ble Central Administrative Tribunal, while disposing of the OA had directed J&K Public Service Commission not to declare the result of the applicants without the leave of the Hon'ble Tribunal; and,
- 3. Whereas, the applicants filed a fresh OA No 1119/2022, seeking declaration of their result. Accordingly, the result of the applicants was submitted before the Hon'ble Central Administrative Tribunal, on 28.11.2022, in a sealed cover, wherein it was declared that three candidates namely Faheem Tahir Qureshi, Tanveer Ahmad Ganai and ShahnShah Kaloo only have qualified for the interview. Hon'ble Central Administrative Tribunal vide its order dated 28.11.2022, directed as under;

"Respondents are directed to allow these three above mentioned applicants to file detailed application by tomorrow i.e. 29.11.2022 for further interview to be held by PSC. It is made clear that though the applicants are allowed to participate in the final interview, result will not be declared till the final decision in the OA".

4. Whereas, in view of the above quoted directions the supra three applicants were allowed to participate in the interview/via voice.



- However, the result of the applicants was not declared in view of the supra Hon'ble Central Administrative Tribunal directions; and
- 5. Whereas, the applicants then filed MA No 39/2023, in OA No 1119/2022, for modification of the order darted 28.11.2022, with the request to direct the respondent Commission to declare the result of the applicants namely Faheem Tahir Qureshi, Tanveer Ahmad Ganai and ShahnShah Kaloo and if any of the applicants has made the grade, the respondents may be directed to conduct the medical examination of the said applicant. The Hon'ble Central Administrative Tribunal while disposing of the MA vide its order dated 06.02.2023, has directed as under;

In view of the above, MA is disposed of with a direction to the respondents to declare the result of the concerned applicant/candidate and conduct the medical examination of the said candidate as per rules and dates as scheduled by the respondents".

6. Now, therefore, in compliance to the supra Hon'ble Central Administrative Tribunal, direction dated 06.02.2023, the applicants are informed that none of them had qualified for the Medical Examination. The detailed marks of the applicants are tabulated here-in-below:
