Whereas, 06 posts of Assistant Professor (Microbiology) in GMC-Handwara, GMC-Udhampur GMC- Anantnag & GMC- Doda, were advertised vide Notification No. 30-PSC (DR-P) of 2022 dated 30.12.2022 and No. 31-PSC (DR-P) of 2022 dated 30.12.2022; **and,**

Whereas, the written test for the posts was conducted on 25.05.2023 and the result of written test was declared vide Notification No. PSC/Exam(s)/2023/29 dated 26.06.2023. The interview was conducted on 06.07.2023; **and,**

Whereas, the Provisional Select Lists was issued vide Notification No. 38-PSC (DR-S) of 2023 dated 07.07.2023 subject to objections, if any, which were to be submitted within 5 days; **and,**

Whereas, following four representations have been received in Commission:-


Sr. No.	Name of the candidate	Objection
01	Suboor Ahmad Naik	He has been called for interview and appeared for the same. However, his name does not figure in the Provisional Select nor in the general merit list
02	Javaid Ahmad Bhat	-do-
03	Tufail Ahmad	Many of the candidates who do not possess prescribed qualification (MBBS) were issued the admit cards and appeared in the screening test. Since they do not meet the criteria for the post, thus has requested to look into the matter and exclude such candidates so that the rule of law is implemented at all stages of the selection.
04	Saqib Rishi	The applicant has been dropped and not included in shortlist of interview for the post of A.P Micro Biology in

		GMC Handwara, instead Dr. Amir Ali (Roll No. 720024) has been shortlisted for the post despite being ineligible for not having requisite experience of 2 years.

Whereas, the representations of the above candidates have been examined as under:-

Sr. No.	Disposal
01	The applicant is non-MBBS having Masters Degree in Clinical Micro-biology, which is not the relevant qualification as per the method of recruitment mentioned in the advertisement Notification. Therefore, his result has not been declared.
02	The applicant is non-MBBS having Masters Degree in Micro-biology and P.hD in micro-biology. Whileas, as per recruitment rules for the post, the requisite qualification is MBBS with M.Sc in Medical Micro biology and P.hD in Medical Micro-biology. The candidate is not fulfilling the basic eligibility for the post.
03	The allegation is not specific. No candidate who does not meet the eligibility has been selected.
04	The objection was not found correct as Dr. Amir Ali has the requisite experience of more than 2 years as Senior Resident as per the certificate issued by Dean Medical Faculty SKIMS Srinagar.

Now, therefore, the representations are disposed off, being devoid of any merit.
