1. Whereas, the J&K Public Service Commission conducted the Written Test for filling up of post of Works Manager, 2023 in Transport Department, Jammu and Kashmir, on 21.07.2023; and
2. Whereas, the Provisional Official Key was notified and uploaded on the official website of the Commission for information of the candidates on 21.07.2023, inter-alia notifying that, if any candidate feels that the keys to any of the questions is wrong/incorrect, he/she may prefer a representation/objection on the prescribed proforma to the Controller of Examinations within a period of three days from the date of its notification, i.e. upto 26.07.2023 (5:00 p.m.) along with documentary proof/evidence and the fee of Rs. 500/- per question; and
3. Whereas, in response to the said notification, three (03) representations were received by the J&K Public Service Commission against Provisional Answer Keys issued; and
4. Whereas, all the objections/representations were referred to the Committee of Experts as envisaged in Rule 10 (d) of the J&K Public Service Commission (Conduct of Examination) Rules, 2022, as amended from time to time, for Independent Expert opinion; and
5. Whereas, the independent team of Experts have recommended changes in the Provisional Official Keys in respect of the said paper;

Now, therefore, in view of the above and on the basis of opinion of the independent team of Experts, it is hereby notified that:-

- a) The changes recommended by the Committee of Experts are hereby adopted and the Final Official Key is annexed to this notification. In terms of Rule

10 (d) of the J&K Public Service Commission (Conduct of Examination) Rules, 2022 as amended upto date, the marks allocated to the deleted questions ***shall be individually added to the marks secured by the individual candidates to ensure that the marks allocated for the question paper as a whole remain unchanged***, at the time of calculation/compilation of award sheet before the declaration of the result;

b) The amount deposited @ Rs 500/- per question is also hereby released in respect of genuine/correct representations and same shall be transferred through RTGS in individual account of candidates.


