Whereas, vide Notifications No. PSC/Exam/2021/21 dated 08.03.2021 & No. PSC/Exam/2023/03 dated 26.05.2023, application forms from the desirous eligible candidates for appearing in Excise and Commercial Part-II Departmental Examination, were invited. In response to these notices, 157 applications (under Notification No. PSC/Exam/2021/21 dated 08.03.2021) and 29 applications (under Notification No. PSC/Exam/2023/03 dated 26.05.2023) were received.
