**Sub: Declaration of the result of J&K Prosecuting Officer (G) Examination, 2022.**

The Home Department on 29.08.2022 referred 120 posts of Prosecuting Officers to the J&K Public Service Commission for being filled up through Competitive Examination -2022.

Accordingly, these posts were advertised by the Commission on 03.10.2022. The Preliminary Examination was conducted on 29.01.2023 in which **2423** candidates appeared in full. The result of the preliminary examination was declared on 27.03.2023. 821 candidates were declared to have qualified for appearing in the Main (Written) examination of J&K Prosecuting Officer (G) Examination, 2022.


The (Main) Examination was held from 31.05.2023 to 17.06.2023. The result of the Mains Examination was declared on 02.08.2023. 341 candidates were declared to have qualified for appearing in the interview/personality test. The interviews were held from 04.09.2023 to 15.09.2023.

The Commission in its Extra Ordinary Meeting held today on 15.09.2023 decided to declare the result of the candidates who appeared in the interview and also to notify their aggregate marks while publishing a list of candidates to be summoned for Medical Examination in accordance with the relevant rules.

**The Commission congratulates Ms. Sanah Badyal D/o Ajit Badyal, R/o Trikuta Nagar, Jammu for securing first position by obtaining 1061.50 marks.**

One hundred seventeen (117) candidates have been declared to have qualified, for the Medical Examination which will be conducted at the Government Medical Colleges of Jammu/Srinagar/ Anantnag/ Baramulla/ Handwara/Doda/ Kathua/ Rajouri/ Udhampur on 20<sup>th</sup> of September.

The J&K Public Service Commission completed the process of examination in a record period of one year. It is pertinent to mention that this is the second such selection of Prosecuting Officers in the last 12 months.
