Whereas, Higher Education Department, vide letter no. HED-GAZ/85/2022-04 dated 24.03.2023, referred eight (08) posts (OM: 05, SC: 01, ST: 01, RBA: 01) of Assistant Professor (Clinical Biochemistry), to the J&K Public Service Commission, for selection of suitable candidates; *and*,

Whereas, the J&K Public Service Commission, vide Notification No. 17- PSC (DR-P) OF 2023 dated: 15.05.2022, advertised the said posts for selection; *and*,

Whereas, a written test was conducted on 27.08.2023. The result of the written test was declared vide Notification No. PSC/Exam/S/2023/51 dated: 12.09.2023, in pursuance of Rule 42 of J&K Public Service Commission (Conduct of Examination) Rules, 2022 and Rule 31 of J&K Public Service Commission (Business & Procedure) Rules, 2021, as amended up-to-date. Thirty (30) candidates were called for interview; *and*,

Whereas, the viva-voce of the candidates was conducted on 18.09.2023 with the assistance of Experts.

Now, therefore, on the basis of the performance in the written test, interview, and other related parameters, in pursuance of Rule 45 of the J&K Public Service Commission (Business & Procedure) Rules, 2021, the merit of the candidates who appeared in the interview is enclosed as **Annexure-**"**A**" to this Notification.

Consequent upon the above-given facts, provisional select list of the candidates as per merit, is given in **Annexure-B** to this Notification.
