Whereas, the Transport Department, vide letter No. TR-9/SMG/2015-II dated 29.09.2020, referred **01 post** under open category of **Works Manager**, to the J&K Public Service Commission, for selection of suitable candidates; **and,**

Whereas, the J&K Public Service Commission, vide Notification No. 07- PSC (DR-P) OF 2021 dated: 19.07.2021, advertised the said posts for selection; **and,**

Whereas, written test was conducted on 21.07.2023. The result of the written test was declared vide Notification No. PSC/Exam/S/2023/44 dated: 28.08.2023, in pursuance of Rule 42 of J&K Public Service Commission (Conduct of Examination) Rules, 2022 and Rule 31 of J&K Public Service Commission (Business & Procedure) Rules, 2021, as amended up-to-date; **and,**

Whereas, 05 candidates qualified for interview; **and,**

Whereas, the interview/viva-voce of candidates was conducted on 04.10.2023 with the assistance of Experts from outside of the UT.

Now, therefore, on the basis of the performance in the written test, interview, and other related parameters, in pursuance of Rule 43(ii) of the J&K Public Service Commission (Business & Procedure) Rules, 2021, the merit of the candidates who appeared in the interview is enclosed as **Annexure** to this Notification.

On the basis of performance in the interview, the weight-age earned in the written test & other attributes, none of the candidates could cross the benchmark as envisaged in J&K Public Service Commission (Business & Procedure) Rules, 2021. As such, no provisional Select List is issued against the post. The merit of the candidates who appeared in the interview is enclosed as **Annexure** to this Notification. Objections, if any, may be submitted to the Commission within five days for examination and disposal. No claim, whatsoever, shall be entertained after five days from the date of issuance of Notification.
