Whereas, the J&K Public Service Commission, vide Notification No. 17- PSC (DR-P) OF 2023 dated: 15.05.2023, advertised the said posts for selection; **and**,

Whereas, written test was conducted on 27.08.2023. Whereas, the interview/viva-voce of candidates was conducted on 04.10.2023 with the assistance of Experts from outside of the UT.
