*Whereas, the Higher Education Department, vide letter No. HED-GAZ/85/2022-04 dated: 24.03.2023, referred twenty one (21) posts (OM: 10, SC: 02, ST: 02, ALC: 01, SLC: 01, RBA: 02, PSP: 01, EWS: 02) of Assistant Professor (Veterinary Technology) to the J&K Public Service Commission, for selection; and,*

*Whereas, the J&K Public Service Commission, vide Notification No. 17-PSC (DR-P) of 2023 dated: 15.05.2023, advertised the said posts; and,*

*Whereas, the written test was conducted on 27.08.2023 and the result of the written test was declared vide Notification No. PSC/Exam/S/2023/51 dated: 12.09.2023; and,*

*Whereas, the viva-voce of the candidates was conducted on 18 & 19.09.2023; and,*

*Whereas, provisional Select List was issued vide Notification No. 56-PSC(DR-S) of 2023 dated 20.09.2023; and*


*Whereas, the Select List was provisional, subject to objections, which were to be received within five days; and,*

*Whereas, a representation has been received against the Provisional Selection of Mr. Zahid Farooq, under RBA category, that he is not having any teaching experience, relevant for the post, from any college, as such is not entitled to marks awarded to him for experience.*

Whereas, the representation was examined, and it was found that the selected candidate, under RBA category, namely, Mr. Zahid Farooq actually does not possess the experience. The matter was placed before the Commission and the Commission in its 21st extraordinary meeting held on 10.10.2023 approved to deduct the points awarded to Mr. Zahid Farooq for experience, and to revise the select list under RBA category.

Now, therefore, the provisional Select List, under RBA category, notified vide Notification No. 56-PSC (DR-S) of 2023 dated: 20.09.2023 is revised in the manner given below;
