- Whereas, the J&K Public Service Commission conducted the Written Test for filling up of posts of Assistant Professor(s) (Dermatology, Venereology & Leprosy), Tuberculosis & Respiratory Diseases, Anesthesiology, Medical Record Officer, Casualty Medical Officer and Librarian in Health and Medical Education Department, on 29.10.2023; and
- 2. Whereas, the Provisional official key(s) was notified and uploaded on the official website of the Commission for information of the candidates on 29.10.2023, inter-alia notifying that, if any candidate feels that the keys to any of the questions is wrong/incorrect, he/she may prefer a representation/objection on the prescribed proforma to the Controller of Examinations within a period of two days from the date of its notification, i.e. upto 31.10.2023 (5:00 p.m.) along with documentary proof/evidence and the fee of Rs.500/-per question; and
- 3. Whereas, in response to the said notification, number of objections/ representations were received by the J&K Public Service Commission against Provisional Answer Key(s) issued; and
- 4. Whereas, all the objections/representations were referred to the Committee(s) of Experts as envisaged in Rule 10 (d) of the J&K Public Service Commission (Conduct of Examination) Rules, 2022, as amended from time to time, for Independent Expert opinion; and
- 5. Whereas, the independent team of Experts have recommended changes in the Provisional Official Keys in respect of the said papers;

Now, therefore, in view of the above and on the basis of opinion of the independent teams of Experts, it is hereby notified that:-

A.

- a) The changes recommended by the Committee(s) of Experts are hereby adopted and the Final Official Key(s) are annexed to this notification as Annexure A, B, C, D, E and F in respect of Assistant Professor(s) (Dermatology, Venereology Leprosy), & **Tuberculosis** Respiratory Diseases, Anesthesiology, Medical Record Officer, Casualty Medical Officer and Librarian in Health and Medical Education Department respectively. In terms of Rule 10 (d) of the J&K Public Service Commission (Conduct of Examination) Rules, 2022 as amended upto date, the marks allocated to the deleted questions shall be individually added to the marks secured by the individual candidates to ensure that the mark(s) allocated for the question unchanged, at the whole remain calculation/compilation of award sheet before the declaration of the result:
