Subject: J&K Combined Competitive Examination 2022- rejection of candidature thereof.

Reference:-Extra Ordinary Meeting of the Commission (Agenda Item No.22.01) Dated 12.10.2023- Decision thereof.

1. Whereas, the General Administration Department, vide Communication No. GAD-SERVOKAS/575/2021-02-GAD dated 18.04.2023, referred 220 posts to the J&K Public Service Commission for being filled up through the Combined Competitive Examination; and,
2. Whereas, these posts were advertised by the Commission vide Notification No. 08-PSC(DR-P) of 2023 dated 19.04.2022; and,
3. Whereas, after conducting the Preliminary Examination, 4944 candidates were admitted to the Main Examination, out of which 3891 candidates appeared and 787 candidates were declared to have qualified for interview vide Notification No. PSC/Exam(s)2923/25 dated 22.06.2023, which was conducted w.e.f 10.07.2023 to 22.08.2023; and,
4. Whereas, vide Notification No. PSC/Exam/2023/S/37 dated 22.08.2023 the result of the candidates was notified for Medical Examination; and,
5. Whereas, in Result Notification No. PSC/Exam/2023/S/37 dated 22.08.2023, it was expressly stipulated below NOTE that mere calling a candidate for Medical Examination shall not confer any right on him/her to be recommended for selection, and the lists notified as Annexure I & II to the notification are provisional; and
6. Whereas, the Commission received a copy of letter No. TH/BCG/231 dated 23.08.2023 from Tehsildar Haveli (Poonch) addressed to Deputy Commissioner Poonch and a copy endorsed to this office, wherein it was reported that it seems EWS category certificates issued for Central Government Jobs have been utilized by the candidates for getting benefit in the J&K CCE-2022 which is contrary to Law. This was reported in the context of two candidates, namely, Jasmeet Kour Sudan D/o Joginder Singh and Ms Jasreen Kour; and,

7. Whereas, it was decided to take up the matter with the concerned Tehsildars in all the cases where clarification was found to be required; and,

8. Whereas, the reports received from concerned Tehsildars in respect of the following candidates are reproduced bellow:-

Whereas, the reports were, inter-alia, also called from the concerned Tehsildars in respect of the following candidates, who figured in Annexure-I of Notification No.psc/Exam/2023/S/37 dated 22.08.2023. The reports received from concerned Tehsildars in respect of these candidates is reproduced below:

10. Whereas, in view of the reports of the concerned Tehsildars, the EWS certificates of the above candidates cannot be considered/used for seeking selection/appointments for the post of J&K Combined Competitive Examination 2022 in the UT of Jammu and Kashmir.

Now, therefore, the candidature of the candidates, mentioned at note-para 8, who have been declared to have provisionally qualified for Medical

Examination for the post of J&K Combined Competitive Examination-2022, under EWS category, and the candidature of the candidates mentioned at note-para 9 is hereby rejected ab-initio for the posts under J&K Combined Competitive Examination 2022.
